- **A.** Update of Comfort Dog Rocco Deputy Chief Derman said that the comfort dog is learning quickly, and is being trained by Officers Lange and Deol. Rocco is learning obedience, including "paws up," whereby he learns to sit and put his paws on the lap of the person sitting.
- **B.** Update on Part-Time Officers Deputy Chief Derman said that there has been a slight setback in hiring two more part-time officers. Both officers turned down the City's offer one because of travel time and the other because of insurance costs. The Police Department is still looking for more part-time candidates, and is still posting the job. He noted that the Police are at full staff for full-time officers.
